Arrangements for Yr5 children & Yr6 children not attending the Isle of Wight trip

We are pleased to be able to confirm the arrangements for Year 5 children & Year 6 children not attending this year's Isle of Wight trip from 24th – 28th June 2024. As well as themed activity and sports events in school, the children will have the fantastic opportunity to participate in two special off-site days which fulfil their outdoor adventurous activities curriculum requirements, which are detailed below.

Activity Day at White Oak Leisure Centre – Wednesday 26th June

The children will spend the day at White Oak and take part in a range of activities.

- Tag Active
- Trampolining (with a coach)
- Swimming

Outdoor Adventure Day at Thriftwood Scout Centre – Friday 28th June

The children will travel to and from the Thriftwood Scout Centre in Brentwood, Essex by coach. Whilst at the centre they will have the opportunity to take part in:

- Vertical assault course
- Cresta run
- Archery
- Water roller

The cost for the week, including the trips and in school activities will be **£52** per child.

We do appreciate that this is a lot of money and therefore are happy for you to pay this in two instalments.
